**DECISION OF THE BOARD OF MEMBERS OF  
MAYBANK SECURITIES LIMITED**

**THE BOARD OF MEMBERS**

- According to the current Charter of Maybank Securities Limited (“the Company”), amended from time to time (“Charter”);
- According to the meeting minutes of the Board of Members on 09 December 2025.

**HEREIN DECIDES**

**Article 1.** THAT the partial conversion of the credit facility of USD19,000,000 offered by KEB Hana Bank – Hong Kong Branch which has been approved by the Board of Members of Maybank Securities Limited according to the Decision No. 0906-3/25/QĐ-HĐTV dated 09 June 2025 into a VND credit facility at KEB Hana Bank – Ha Noi Branch be approved as follows:

- a. Credit facility before the conversion: USD9,500,000 (*in words: nine million, five hundred thousand US dollar*).
- b. Credit facility after the conversion: VND240,000,000,000 (*in words: two hundred and forty billion Vietnam dong*).
- c. Purpose: to finance working capital for licensed operation of the Company.
- d. Facility period: Facility period will end on one of the following dates, whichever is earlier:
  - i. one (01) year from the disbursement date;
  - ii. five (05) working days prior to the expiry date of the Standby Letter of Credit.
- e. Collateral: Unconditional and irrevocable Standby Letter of Credit issued by the Guarantor which is Malayan Banking Berhad (Maybank) - Ho Chi Minh City Branch or any branch of Maybank. Guarantor shall issue Standby Letter of Credit by SWIFT, securing the Borrower's obligations at KEB Hana with the Guaranteed Amount of 100% of total loan amount after the conversion.

**Article 2.** THAT Mr. Kim Thien Quang, Chief Executive Officer or Ms. Nguyen Vo Van Ha, Chief Financial Officer be authorized to implement and sign, on behalf of the Company all the relevant documents including the Credit Agreement, Letter of Offer, Loan Acknowledgement, Payment Commitment, Mortgage/Pledge Agreement, and other relevant

documents deemed necessary and appropriate with KEB Hana Bank, in line with the aforesaid decision and pursuant to the prevailing laws and regulations.

**Article 3. THAT** the Decision takes effect from the signing date and is an integral part of the Decision No. 0906-3/25/QĐ-HĐTV dated 09 June 2025 of the Board of Members of Maybank Securities Limited.
